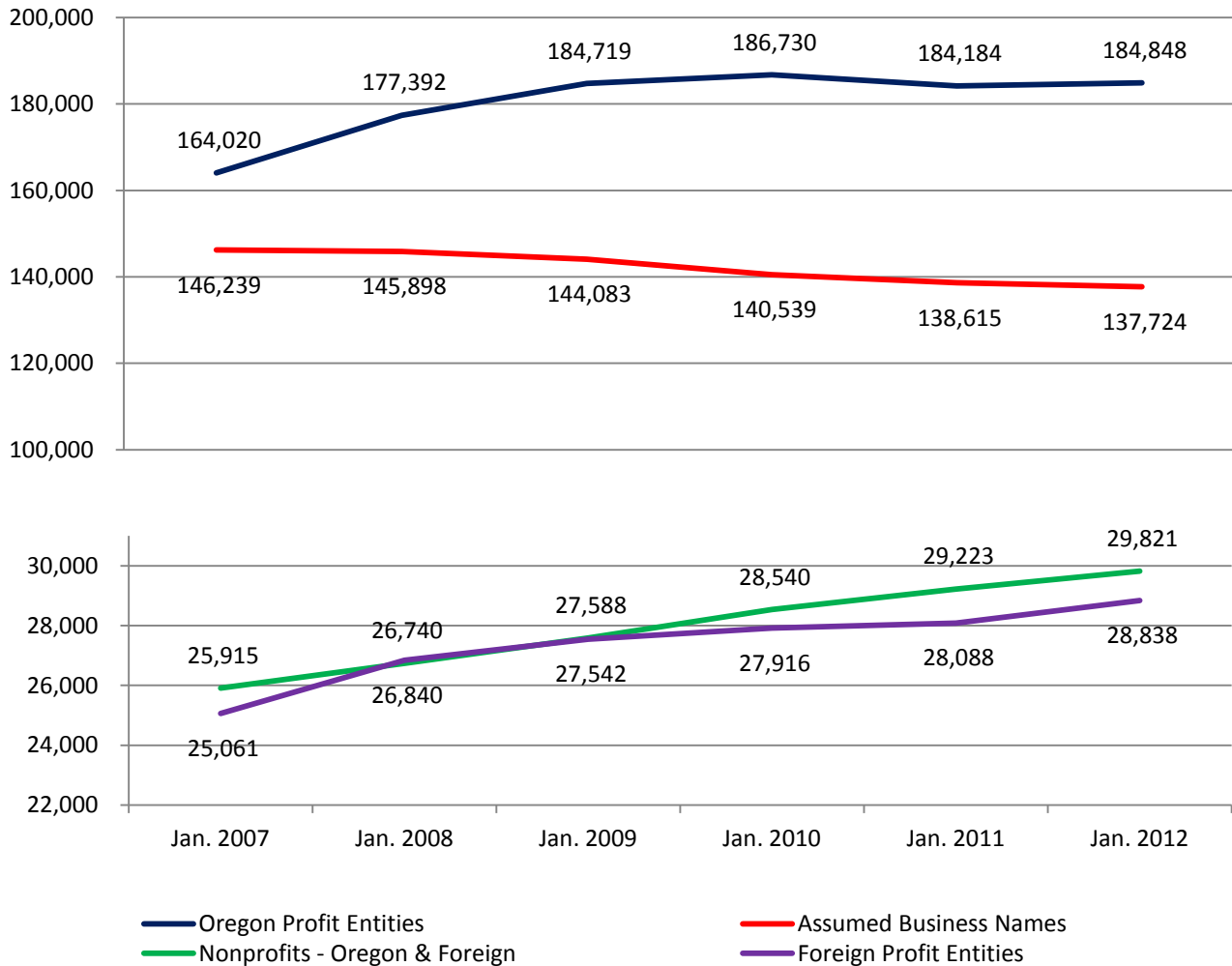


ACTIVE BUSINESS REGISTRATIONS IN OREGON



Oregon Profit Entities: include all active business corporations, cooperative corporations, professional corporations, water district corporations, limited liability companies, limited liability partnerships, limited partnerships, and business trusts created under Oregon law.

Assumed Business Names: include active 2-year assumed business names registered under Oregon law.

Nonprofits: include all nonprofit corporations created under law in, or outside of Oregon.

Foreign Profit Entities: include all active business corporations, professional corporations, limited liability companies, limited liability partnerships, limited partnerships, and business trusts created under laws outside of Oregon.
